Instruction & Contact

I understand that in order to provide the student with quality instruction, the use of hands on contact is a vital component to aid in the learning of proper body alignment, turn-out, and placement.

Liability & Medical Consent

I agree that I will not hold Maryland Youth Ballet (hereafter referred to as "MYB"), or any MYB faculty member, other employee, or contractor, liable for injuries sustained or illness contracted by the student during the attendance of classes, rehearsals or any related functions. This includes any and all online video classes, instruction, and other learning experiences provided by MYB.

Students with severe or life-threatening medical conditions (meaning the student may require professional medical intervention and health needs beyond hydration or rest) must have a guardian present during the entirety of class.

I agree that the use of the website shall be at my own risk and MYB is not liable for any interruption of transmission, any bugs, viruses, trojan horses or the like, which may be transmitted to and through the website.

I agree that this accident waiver and general release of liability shall be broadly construed to provide a release and waiver to the maximum extent permissible under applicable law.

I authorize MYB to call 911 for emergency treatment for my child on my behalf if I am not able to be reached. I further release MYB from all liabilities for injuries or damages arising out of personal injury of any kind.

Tuition Payments & Refunds - Youth, Pre-Professional and MYB Extension

I understand that tuition is payable in full at the time of registration with a credit/debit card. If not paid in full at registration, automatic installment payments must be set-up with a credit/debit card. Installment payments cannot be canceled after the first two (2) weeks of my child's enrollment. Installment payments can be made through the Parent Portal (preferred) or in person with cash prior to the scheduled due date. Accounts 7 days late will incur a \$45 late fee.

I understand that I am responsible for the full tuition for the entire school-year for which I am registering my child, unless they withdraw within the first two (2) weeks of their enrollment. Withdrawals must be made through email or in writing prior to the start of classes or during the two (2) week withdrawal period.

Prior to and during the first two (2) weeks from the beginning of enrollment, all amounts paid for tuition are refundable (prorated) minus the non-refundable deposit (amount varies by level; see your registration confirmation for the applicable amount) and any fees (including the registration fee, late fees and returned check fees).

I understand that after the first two (2) weeks of my child's classes, I am responsible for the entire tuition balance whether or not my child continues to attend MYB during any remaining portion of their enrollment. After the first two (2) weeks from the beginning of my child's enrollment, all amounts paid or required to be paid for tuition and fees are non-refundable and non-cancelable.
